In accordance with a letter agreement between Communication Workers of America - Local 9510, hereinafter referred to as CWA and the American Arbitration Association, hereinafter referred to as AAA, an Election of Officers was conducted among the membership of the union.

AAA attended the Nomination Meeting on September 5, 2023. At that time, it was determined that one office in the AT&T unit had opposition, and all other offices white-balloted. Ballots and White Ballot Notices were mailed out on September 15, 2023 to one thousand three hundred seventy-two (1,372) CWA members. An additional twelve (12) duplicates were mailed throughout the duration of the election at the request of the union. In order for the ballots to be valid and counted, the ballots were required to be returned and received by the Foy Station Post Office by 9:00 a.m., Monday, October 2, 2023.

CWA provided the AAA with an alphabetical list of persons who were eligible to vote.

The counting of the ballots took place at the AAA's Los Angeles office located at 725 S. Figueroa St., Suite 400, on Monday, October 2, 2023. Secrecy of the ballot was maintained at all times.
